## INTRODUCTION

This Manual has been prepared in accordance with section 51 of the Act and aims to facilitate a Request for access to a Record held by a private body that is required for the exercise or protection of any rights.

## DEFINITIONS

Unless the context clearly indicates otherwise, the following terms shall have the meanings assigned to them hereunder, namely -

- “Act” means the Promotion of access to Information Act, Act 2 of 2000, as amended from time to time;
- “The Foundation” means The People for Ukajede Foundation Ltd as more fully described in the overview hereunder;
- “Guide” refers to the guide drafted and made available by the Information Regulator to inform the Requester on how to access Records
- “Information Regulator” means the regulator with the powers and functions set out in s40 of the Protection of Personal Information Act (4 of 2013);
- “Information Officer” means the person acting on behalf of The Foundation and discharging the duties and responsibilities assigned to the head of The Foundation by the Act. The Information Officer is duly authorised to act as such and such authorisation has been confirmed by the “head” of The Foundation in writing;
- “Manual” means this manual published in compliance with Section 51 of the Act
- “Record” means any recorded information, regardless of form or medium, which is in the possession or under the control of The Foundation, irrespective of whether or not it was created by The Foundation;
- “Request” means a request for access to a Record of The Foundation;
- “Requestor” means any person, including a public body or an official thereof, making a Request for access to a Record of The Foundation and includes any person acting on behalf of that person; and
- “SAHRC” means the South African Human Rights Commission.

Unless a contrary intention clearly appears, words signifying:-

- the singular includes the plural and vice versa;
- any one gender includes the other genders and vice versa; and
- natural persons include juristic persons.

Unless otherwise stated, terms defined in the Act shall have the same meaning in this Manual.

## OVERVIEW OF THE PEOPLE FOR UKAJEDE FOUNDATION

The People for Ukajede Foundation is a registered non-profit organization established in accordance with the company laws of South Africa.

The People for UKAJEDE Foundation has been running since 2004 and is a registered non-profit organization. The project was initially started by The Birchwood Hotel supporting 5 crèches in the local informal settlements in the East Rand. The area has become known as “UKAJEDE” which is an acronym for the 5 areas within the informal settlement – Ulana, Kanana, Angelo, Jerusalem and Delmore. Over the years the project has expanded to support 8 crèches, the main focus being to provide a sustainable feeding program that ensures the children receive a daily cooked meal and a secure environment in which to learn.

## 7. ACCESS: PROCEDURE, AVAILABILITY AND FEES

### 7.1 How to Request a Record (Section 53)

- A Request for access to a Record as contemplated in 53(1) of the Act, must be made on a form that corresponds substantially with Form 2 of Annexure A, to the Information Officer. The Information Officer must, if a Request for access to a Record is made orally as a result of illiteracy or a disability of a requester, complete Form 2 of Annexure A to the Regulations on behalf of the Requester and provide a copy thereof to the Requester. Failure to make use of the prescribed form could result in a Request being refused or delayed. A Request for access to a Record must be accompanied by payment of an initial non-refundable Request fee of R57.00 (inclusive of VAT). This fee is not applicable to personal Requests, i.e. individual seeking access to Records pertaining him/herself.
- The Requestor must provide sufficient detail on the Request form to enable the Information Officer to clearly identify the Record as well as the Requestor's identity, which is to be accompanied by positive proof of identification.
- The Requestor must indicate which form of access is required and if he/she wishes to be informed on the decision on the Request in any other manner, to state the necessary particulars to be so informed.
- Access is not automatic. The Requestor must therefore identify the right he/she is seeking to exercise or protect and provide an explanation as to why the requested Record is required for the exercise or protection of that right.
- If a Request is made on behalf of a person, the Requestor must then submit proof, to the satisfaction of the Information Officer, of his/her authority to make the Request. Failure to do so will result in the Request being rejected.

### 7.2 Decision on Request (Section 56)

- The Requestor will be notified, within 30 days, in the manner indicated by him/her of the outcome of his/her Request, alternatively whether an extension not exceeding 30 days is required to deal with the Request.
  - If the Request for access is granted a further access fee must be paid for the reproduction as well as the search and preparation of the Records and for any time that has exceeded the prescribed hours to search and prepare the Record for disclosure. Access will be withheld until the Requestor has made payment of the applicable fee(s)
  - In the event that the Request for access is refused, reasons for the refusal will be provided and the Requestor will be advised the he/she may lodge an application with a court against the refusal of the Request, as well as the procedure for lodging the application
- The Requestor may lodge an internal appeal or an application to court against the tender or payment of the Request fee.
